

**SCHEDULE "A" TO BY-LAW 2023-02
OF THE TOWNSHIP OF ATHENS
CLASSES OF PERMITS AND PERMIT FEES**

CLASS OF PERMITS	FEES
BUILDING PERMIT (BASE FEE)	To construct a building (including repairs and alterations) \$18.00/\$1,000.00 building value, minimum permit fee applies.
MINIMUM PERMIT	Construction cost up to \$10,000 minimum fee is \$182.00. Construction cost \$10,000 - \$20,000 minimum fee is \$364.00. For construction cost over \$20,000 the base fee applies.
REVISION PERMIT	\$18.00 / \$1,000.00 building value. Minimum permit fee applies.
DEMOLITION PERMIT	\$18.00 / \$1,000.00 demolition value. Minimum permit fee applies.
HEATING/VENTILATION/AIR CONDITIONING SYSTEMS (HVAC)	\$18.00 / \$1,000.00 system value. Minimum permit fee applies.
CONDITIONAL PERMIT	To construct a building \$18.00 / \$1,000.00 building value. Minimum permit fee applies.
SWIMMING POOL ENCLOSURES	\$18.00 / \$1,000.00 building value. Minimum permit fee applies.
HEAT PUMP – GROUND SOURCE / WATER SOURCE	\$123.00
SOLID FUEL BURNING	\$123.00
OCCUPANCY PERMIT	\$123.00
CHANGE OF USE PERMIT	\$329.00
IN FLOOR RADIANT HEATING SYSTEMS	\$123.00
PLUMBING PERMIT	\$173.00
TRANSFER OF PERMIT	\$123.00
BUILDING CODE VIOLATION INSPECTION	\$174.00
MISSED INSPECTION	\$123.00 (imposed on a per project basis after a second inspection has been requested but not cancelled and the inspector cannot perform the inspection due to insufficient construction progress)
BUILDING WITHOUT A PERMIT	\$36.00/ \$1,000.00 building value. Doubled minimum permit fee applies.
BUILDING CODE EQUIVALENCY EVALUATION	\$1303.00(but not including the cost of services by independent consultants or services by others.)

SEPTIC PERMIT	\$697.00
TANK REPLACEMENT	\$348.50
BED REPLACEMENT	\$348.50
TEMPORARY HOLDING TANK	\$123.00
